## Winter Storage Policy

The Clinton County Fair Board offers winter storage for motorhomes, campers, boats, trailers and vehicles.

Storage rates will be charged at a rate of \$10.00 per linear foot (end of hitch to bumper or bumper to bumper). Items will begin being placed in storage no earlier than the 3<sup>rd</sup> week of October. Items will be removed no later than the 3<sup>rd</sup> weekend in March. Contact Lois Block at 563-249-1778 to schedule your storage delivery and pick up times. There will be no adjustment in fees for late arrivals. *There will be a \$200 early removal fee*.

To store items for the winter, you must provide the office with the items listed below. Keep in mind that storage is based on a first come, first serve basis. *Payment must be received on or before the date of storage*.

- □ **Proof of Insurance** (Physical Property Damage and Liability) coverage listing the *Clinton County Agricultural Society as an Additional Insured*. Insurance information should be available from your agent and can be sent directly to the fair office by your insurance company.
- □ *Payment* in full. Make check payable to: Clinton County Agricultural Society.
- □ Completed contract.

## While items are in winter storage the following rules should be followed.

- Stored items should not contain fuel. All removable fuel tanks should be removed.
- Do not plug in stored items.
- Disconnect any batteries in stored items.
- Do not start any motorized items while stored in storage building.
