## **Clinton County Fairground Facilities Rental Contract**

- 1. Deposit & Rental Fee: The Renter will pay the deposit & rental fee in full at time of reservation. It is payable to and will be deposited by Clinton County Agricultural Society. The deposit will be reimbursed if the reservation is cancelled prior to the reserved date. The rental fee will be reimbursed if the reservation is cancelled prior to 90 days in advance of the reserved date. If cancelled within 90 days of the reserved date rental fee will not be reimbursed. The deposit will be reimbursed to the renter within 2 weeks of the event if upon inspection of the rented site it is found to be clean, there is no damage, the Renter adhered to all rules and regulations and the key returned in the drop box.
- 2. Insurance: At least one week prior to the event the Renter will provide proof of 1 million dollars in liability insurance coverage on which the Clinton County Agricultural Society is listed as Additional Insured (sample available) or you can purchase this insurance from the Clinton County Agricultural Society's insurance. The renter is responsible for obtaining and providing the Clinton County Agricultural Society with certificates of General Liability and Liquor Liability on which the Clinton County Agricultural Society is listed as additional insured, pertinent permits and licenses from any contractors and/or subcontractors hired/used by the renter.

#### **Rules, Regulations and Cleaning Procedures**

The Clinton County Fair Grounds and Buildings are to be maintained by those renting the site. Renters agree to comply with the rules and regulations listed below. Failure to do so will result in forfeiture of all or part of the deposit. Call Lois Block at 563-249-1778 if a maintenance problem or damage to the facility occurs while you are occupying the building.

#### **Rules and Regulations**

- 1. Keys can be picked up at the office the week of the event.
- 2. All candles should be in a votive with flame no less than 1 inch from the top of votive.
- 3. Do not attaching anything to the walls and wood doors. Decorations may be hung from the wire along the walls.
- 4. Do not drag tables or chairs.
- 5. Additional tables and chairs are available in the north store room.
- 6. The overhead door in the big room may be used to move large items in and out of the Auditorium.
- 7. Coffee pots, stove, refrigerator and microwave are available for use. A limited supply of cooking/serving utilities, dish clothes and towels are available. It is recommended that you bring your own.
- 8. Restroom supplies are available in the store room near the kitchen.
- 9. No smoking in the building.
- 10. Alcohol must be served by an adult, 21 years of age or older.
- 11. Alcohol must not be left unattended.
- 12. Only beer, wine coolers and champagne may be served. No hard liquor.
- 13. Thermostat will be set by fair board staff.
- 14. The Clinton County Fair Grounds is not associated with 4-H. Do not include "4-H" in the wording when advertising an event at the fairgrounds.

#### <u>Cleaning Procedures</u> Cleaning items are located in the store room near the kitchen.

- 1. Collect all trash and place in dumper in the southeast corner of the fairgrounds.
- 2. Sweep floors of rooms used for the event with large dust mop from the store room near the kitchen.
- 3. Clean up kitchen if used.
- 4. Wipe up all counters, tables and appliances used.
- 5. Make sure all kitchen appliances are off.
- 6. Leave any dirty dishcloths and towels hanging on the utility sink.
- 7. Make sure all lights are off and all doors are locked when leaving.
- 8. Place key in slot to right of the south door.
- 9. If everything is in pre-event condition after the event the deposit will be refunded within 2 weeks of the event.
