Clinton County Fair Food Vendor Application July 20th - 24th, 2022

- Submitting this application does not guarantee space is available. Applicants will be notified of status of application in a timely manner.
- The Fair does not issue exclusivity rights to any vendor for products sold.
- The Fair will monitor products sold in order to hold down duplication of products.
- The Fair reserves the right to restrict products offered by any and all vendors.
- This form is NOT a commitment by the Clinton County Fair to rent space.
- Each Vendor shall obtain and keep in force until completion of the "event", including set up and tear down, a commercial general liability insurance contract with liability limits equal to or greater than \$1,000,000 each occurrence. The Vendor shall **provide a CERTIFICATE OF INSURANCE** to the *Clinton County Agricultural Society* evidencing such coverage within ten days of the signed contract. Such Vendor shall name Clinton County Agricultural Society as an *Additional Insured*.
- **SELLING DATES AND TIMES:** Vendors may open up to 2 hours but no less than 1 hour before events in Main Arena. Vendors need to stay open until the end of the show or 10 pm whichever comes first. Vendor may stay open longer if they wish.
- **VENDOR SET UP:** Contact Lois at 563-249-1778 to set up.
- **VENDOR FEE:** 15% of gross sales less sales tax (if applies). Payment should be made to the fair office at the conclusion of fair on Sunday.
- **ELECTRICITY:** Available for additional charge.
- Each vendor will be responsible for their own admission fees. Admission gates will begin at 3 pm Thursday - Sunday. Wednesday is free all day.
- Vendors are to provide their own tables, drop cords and other items needed.
