CLASSES: FFA Creative Edit Landscape Animals Color

Black & White STATE FAIR THEME: My Advisor

PREMIUMS: Purple - \$2.00 Blue - \$1.50 Red - \$1.00

RULES:

1. Each exhibitor may enter a maximum of 4 photos; limit of two per class. Class(es) entered must be specified at time of entry.

- 2. A photo entered in the wrong class can be moved to the correct class on judging day. No photo can be exhibited in more than one class.
- 3. Photographs shall not have been previously exhibited for 4-H or FFA at county fair or the lowa State Fair.
- 4. All photos must have been planned and taken by exhibitor.
- 5. Pictures may be made by the photographic process in black and white, toned or full color media.
- 6. Photographs may be produced by the FFA member or a commercial laboratory.
- 7. Photographs must have been taken after the last day of last year's fair and before entry day.
- 8. One side of the photograph must have at least 6 ½ inches visible and no side can be more than 14 inches.
- 9. If matted, one side of the matting will be at least seven inches and no side of the matting can be more than 14 inches.
- 10. Photographer's name and picture title should NOT appear on the FRONT of the photographs or matte/mount boards.
- 11. Mounted photographs should not use hooks or wires. DO NOT COVER PHOTOS WITH ACETATE OR GLASS.
- 12. Tape the entry tag string to the upper right-hand corner on the back of the photo.
- 13. FFA photography exhibitors may have a fellow FFA member, parent or someone else deliver the photos. Any photo received after 3 pm on entry day will not be judged.
- 14. All photos PROPERLY entered will be judged. The judges reserve the right to make awards as the quality of the photographs warrant.
- 15. A purple, blue or red ribbon will be awarded to each entry. Premiums will be awarded to all entries. Only purple ribbon winners can be named Champion of a show/class.
- 16. Photos will be displayed on "A"-framed display structures as space allows based on ribbon awarded.
- 17. In no case, will the Clinton County Fair Board nor the FFA Associations of Clinton County be responsible for any loss or damage that may occur.
- 18. All entries must be picked up at release time listed at top of this page. No entries will be released before release time.
- 19. Entries not picked up by Monday following fair may be destroyed.
